



### ODA / JFPM IN UTTARA KANNADA FOLLOW UP STUDY OF VFCs in Uttara Kannada district

#### OBJECTIVE

To understand the progress of JFPM in the village and to learn about its strength and weakness. In past one year the activities like preparing micro plans and signing of MOU [Memorandum of Understanding] have contributed towards empowering VFCs. The study will focus on these process and analyse the situation.

The following issues will be studies:

#### I. ORGANISATIONAL GROWTH
