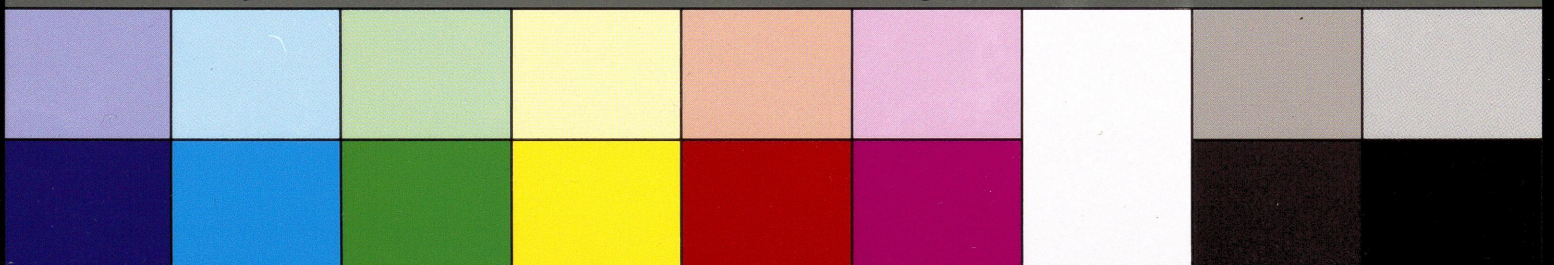

Sub: Remuneration received by the Tutorial Staff of the Mysore
University for working as Examiners of ~~the~~ other Universities.

Reference is invited to Article 69 M.S.R. regarding acceptance of remuneration by Government Servants for work done for a private body or a public body whose funds are not administered by Government. In this connection, I write to state that other Indian Universities are to be treated as Private Bodies for purposes of Art.69 M.S.R. and hence, I request you kindly to intimate whether any of the Teaching Staff of the Mysore University have done any work in connection with the examinations conducted by the other Universities and if so, the remuneration received by them on each occasion from 1-4-1952 may be kindly intimated. Whether there are any orders of Government specifically exempting the University Staff from the operation of Art.69 ~~of~~ M.S.R. may be kindly intimated sending a copy of the same to this office for reference.
