Dear Fr. Julian,

I received your letter an hour ago. Rev. Fr. Provincial's idea was that Fr. Leo's transfer could be put as an agreement between 2 Managements viz B.J.E.S. & M.J.E.S. But -

Both Bro. Goveas & Fr. Walter are of the opinion that this would lead to endless difficulties. As you have mentioned, it is better done at the K.J.E.S. level, viz.

1) A letter from the President, K.J.E.S., to the D.C.E. conveying the appointment of Fr. Julian as President, K.J.E.S., and a request to grant him leave of at

least 3 years. Also requesting the D.C.E. to approve the transfer of Fr. Leo to St. Aloys. College, B'lore.

2) A resolution of the K.T.E.S. Governing Body regarding the transfer of Fr. Leo as Principal, St. Aloys. College, B'lore.






