Dear Sridhar,

I am returning the proof pages for the May-June 2002 issue of the *Newsletter*, having gone through them in detail and making necessary changes. The following points may be kindly noted.

1. My marginal marks in red ink should be suitably incorporated in the copy.
2. On page 'i' the title "PREFACE" should be changed to EDITORIAL. I think this is better for a newsletter.
3. Pages 'ii-iii', section 'References'. Remove the spaces between each reference so that all of them fit on page ii.
4. Insert a sub-title page between pages ii and iii and renumber the remaining pages with the sub-title page being page iii. The matter for the sub-title page is enclosed.
5. This change means re-numbering the following pages from iv-x as well as changing the page numbers in the CONTENTS page.
6. Red-coloured '#' symbols should be placed exactly in alignment with the species as in the mss., that is being returned. My file, has these in place and I do not know how or why they were removed from the mss., sent to me.
7. Page 26. Give a title as inserted by me, to the table of symbols and their description.
8. Shift pages 27-28 to the end and re-number as '36' and '37' respectively. The reason is that these should be the first names available to a person who is flipping the magazine. It is meant to be a quick-reference.
9. The above point will require the re-numbering of pages 29-37 from '27' to '35'.
