Sir,

I have the honour to inform you that the Executive Council at its meeting held on the 21st March 1942 has appointed you Professor of Physics for a period of three years in the first instance on a salary of Rs. 1250/- p.m. in the grade of Rs. 800/50-1250.

2. I beg to add that the University has a Provident Fund to which every teacher of the University is required to subscribe 8% of the salary, the University contributing at the rate of 12% in the case of subscribers drawing a salary of Rs. 500/- or less, 10% in the case of more subscribers drawing a salary more than 500/- but not exceeding Rs. 1,000/-, and 8% in the case of subscribers drawing a salary over Rs. 1,000/-.

3. Under the Allahabad University Act 1921, you will be required to sign an agreement as printed in the Allahabad University Calendar 1941 (pages 415-418) and will be subject to the superannuation rules for the time being in force.

4. An acknowledgment of this letter in token of your accepting the offer is requested.
