Dear Dr. Sreekantan,

The purpose of this letter is to invite you to join as a Life Member of the Institute for Social and Economic Change (ISEC).

As you may know, ISEC is one of the leading research and training institutions in the social sciences in the country. It was established in Bangalore in 1972 largely as a result of the efforts of late Professor V K R V Rao, who received the generous support of the Government of India, Government of Karnataka, the Indian Council of Social Science Research, and the Ministries of Health and Family Planning, and Agriculture. During the last 22 years of its existence, a number of research studies have been carried out by the faculty of the Institute, designed to identify and understand the social and economic changes taking place in our country and also influence, directly or indirectly, the policies of the government. Another aim of the Institute is to keep the interested public aware of issues of importance to the country and to the understanding of which the social sciences have a contribution to make. Lectures and seminars are organized to serve this, and besides internal seminars are held regularly for the benefit of the faculty and students.

ISEC is an autonomous organisation registered as a Society under the Karnataka Societies Registration Act. The Governor of Karnataka is the ex-officio President of the Society. The management vests in the Board of Governors which includes representatives of the Indian Council of Social Science Research, Government of Karnataka, Government of India, and a few eminent persons elected by the General Body. When the Society was formed, Founder Members were enrolled from all over the country. However, with the passage of time, we have unfortunately lost several of them. We would therefore now like to enlarge the life membership base by inviting persons who would be interested in advancing the cause of social science research. Such persons do not necessarily have to be social scientists themselves. Indeed, we would like to draw our membership from a wider cross-section of society, as developments in the society, economy and polity need contributions not only from academics but distinguished civil servants, industrialists and business, professional men and women, and eminent citizens generally.

Under the rules of our Institute, Life membership of ISEC Society is by invitation. We feel that with your rich background and experience, ISEC will benefit by your association with the Institute. I have therefore pleasure in inviting you to be a Life member.

I may mention in this connection that life-members have to pay a one-time contribution of Rs.1,000/-.

I do hope that I can look forward to a positive response from you.


