I thank you very much for your letter of June 22nd.





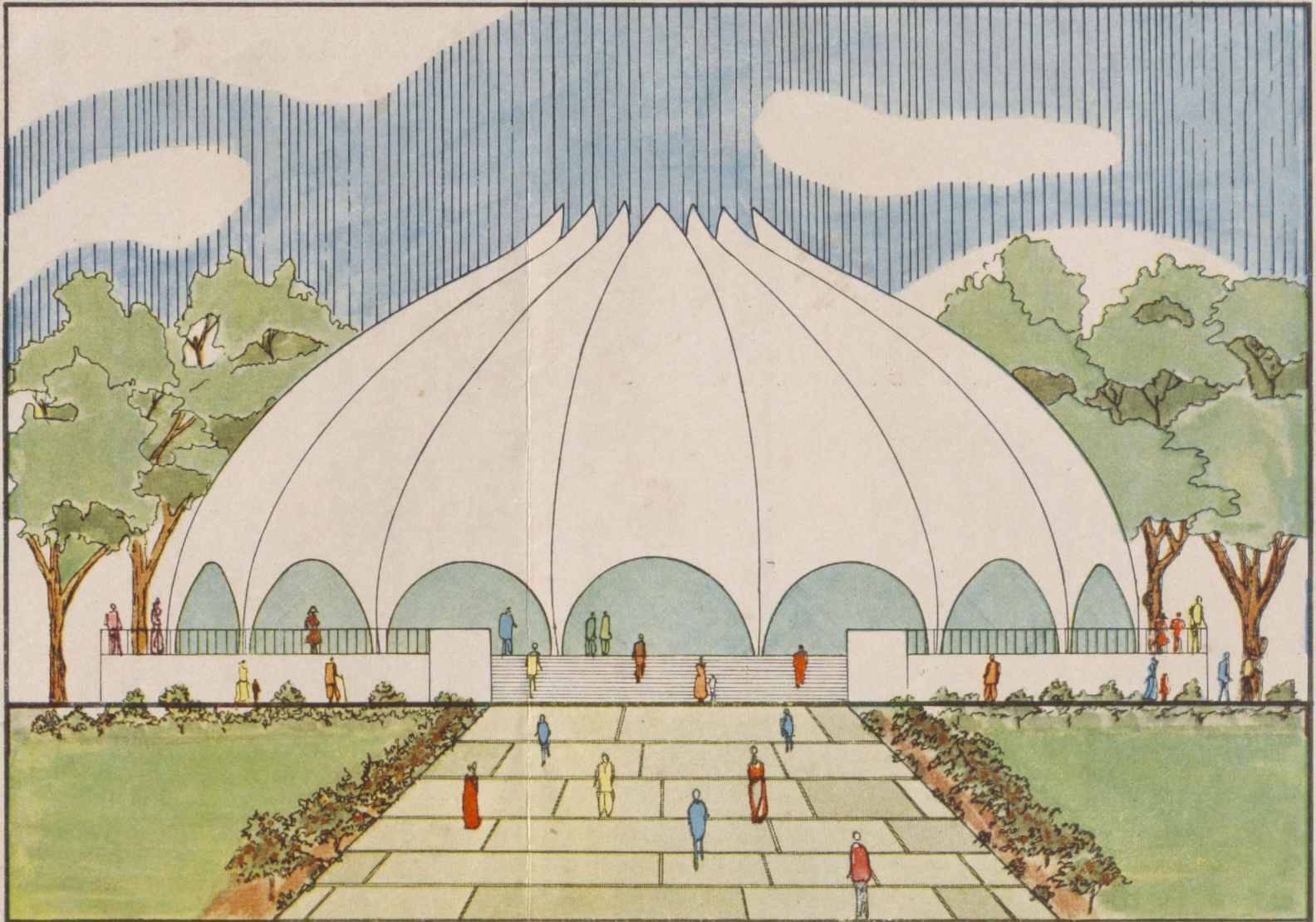
