I am writing with reference to my observation on "nest temperature regulation during incubation in the Ashy Wren-Warbler" that appeared in NCBW vol 34 (2): 29-31. As the tables and figures have not been included with the printed matter, I am afraid, the content may not be as explanatory and interesting to the reader as otherwise. I seek your permission for me to submit it in more elaborate form with the necessary tabular and graphic adjuncts to a scientific journal as per your earlier suggestion. Await your consenting reply. Thank you.

I should thank Mr. Ashesh Pittie for the pains he has taken to index the vols 30-31 of the NCBW, and Mr. Sridhar and you for having brought it out in one simple number (3) of vol 34 of the NCBW. Though I have yet to go through it thoroughly, I should appreciate the attempt. The author's dilemma as to the head, species or biology, under which a paper is to be included is evident. A paper of mine on page 65 could have been under Biology. The same paper has its feet in its position under geographical index. The index must


