

Respected Prof. Sreekantan,

I am in receipt of your letter posted on 20th May, 1993 at Boston. ^{28th}

The work in the Shreyas has been completed at a cost of Rs.800/- and you do not have to worry on the subject as there will not be any leakage in the rainy season as the work of closing AC holes also has been completed.

As far as payment of Electricity Bill is concerned, you are aware that we have collected two bills pertaining to the period January and February, 1993. I then approached Shri Prabhu and Shri Sultaniya in this regard. They have advised me to obtain the bill up to December end 1992 from BEST. As the said bill was not available with them, I have obtained the duplicate bill from the BEST and the decision regarding the amount payable by them up to 31st December, 1992 will be sorted out. In the meantime, Shri Prabhu was requesting to refund the deposit made by the company to you as otherwise, he will not issue No Objection Certificate which is required for transferring the meter in your name. For transferring the electricity meter, I have obtained the prescribed form from BEST which is enclosed herewith duly completed to extent possible. It will be appreciated if you will sign the same at the places marked cross on the form and return to me. This form has to accompany N.O.C. from Modi Pawn Ltd. As far electricity meter in Shreyas is concerned the same appears to be disconnected due to nonpayment. I would also be happy to know whether you are available on telephone at the residence as well as on fax so that we can communicate faster.


