Dear Dr Gole,

With reference to our earlier correspondence and telephone conversations regarding participation in the above mentioned symposium organised by Wetlands International (Center for Ecosystem Studies, Alterra in Wageningen), I am happy to inform you that the ministry of Agriculture, Nature & Food Quality in Holland agreed on sponsoring. Financing will be against the actual costs incurred on the following items based on original invoices. The total amount granted is € 1.760,= (approximately Rs 107.300,=) and will be settled against the maximum as mentioned hereunder:

1. International travel costs etc Pune-Delhi-Kiev v.v., approximately Rs 40.500,= (will be settled directly via the Netherlands Embassy in New Delhi)
2. Local transportation Kiev-Odessa v.v., approximately Rs 10.400,=
