I'll likely have spoken with you by phone by the time you receive this letter. I can't wait to hear about the baby. Please send Great Uncle George a batch of pictures.

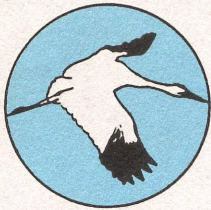
